Impeaching Christopher Asher Wray, Director of the Federal Bureau of Investigation, for facilitating the development of a Federal police force to intimidate, harass, and entrap American citizens that are deemed enemies of the Biden regime.

## RESOLUTION

Impeaching Christopher Asher Wray, Director of the Federal Bureau of Investigation, for facilitating the development of a Federal police force to intimidate, harass, and entrap American citizens that are deemed enemies of the Biden regime.

- 1       *Resolved*, That Christopher Asher Wray, Director of
- 2 the Federal Bureau of Investigation, is impeached for fa-
- 3 cilitating the development of a Federal police force to in-
- 4 timidate, harass, and entrap American citizens that are
- 5 deemed enemies of the Biden regime, and that the fol-

1   lowing articles of impeachment be exhibited to the United  
2   States Senate:

3       Articles of impeachment exhibited by the House of  
4   Representatives of the United States of America in the  
5   name of itself and of the people of the United States of  
6   America, against Christopher Asher Wray, Director of the  
7   Federal Bureau of Investigation, in maintenance and sup-  
8   port of its impeachment against him for facilitating the  
9   development of a Federal police force to intimidate, har-  
10   ass, and entrap American citizens that are deemed en-  
11   emies of the Biden regime.

12       The Constitution provides that the House of Rep-  
13   resentatives “shall have the sole Power of Impeachment”  
14   and that the Director of the Federal Bureau of Investiga-  
15   tion, as a civil officer of the United States, “shall be re-  
16   moved from Office on Impeachment for, and Conviction  
17   of, Treason, Bribery, or other high Crimes and Mis-  
18   demeanors”.

19       In his conduct as Director of the Federal Bureau of  
20   Investigation, in violation of his constitutional oath faith-  
21   fully to execute the office of the Director of the Federal  
22   Bureau of Investigation, and, to the best of his ability,  
23   preserve, protect, and defend, the Constitution of the  
24   United States, Christopher Asher Wray continues to mate-  
25   rially endanger the justice system of the United States and

1 empower President Joseph R. Biden, Jr., to persecute his  
2 political adversaries at will.

3 ARTICLE I

4 Rather than adhering to an oath he took to defend  
5 and secure our country and uphold the Constitution when  
6 he was sworn in as Director of the Federal Bureau of In-  
7 vestigation on August 2, 2017, Director Wray has will-  
8 ingly refused to ensure that the laws passed by Congress  
9 and signed by the President are faithfully executed.

10 Director Wray has failed to uphold his oath and has  
11 instead overseen a denigration of the principles of our  
12 democratic republic by utilizing the Federal Bureau of In-  
13 vestigation as a Federal police force to punish or intimi-  
14 date anyone who questions or opposes the current regime.

15 Director Wray has become a lackey of the Biden re-  
16 gime, persecuting the enemies of his handlers, including  
17 both public and private citizens. The FBI has taken un-  
18 precedented actions to this end:

19 The FBI conducted an unprecedented raid on  
20 the home of the 45th President of the United States,  
21 Donald J. Trump, on August 8, 2022.

22 FBI whistleblower Garret O' Boyle told con-  
23 gressional investigators that the FBI created a ter-  
24 rorist threat tag following the Dobbs Supreme Court  
25 decision in 2022. O'Boyle confirmed that the pur-  
26 pose of the tag was to target pro-life individuals.

1           On September 23, 2022, armed FBI agents in  
2           tactical gear raided the family home of Mark Houck,  
3           a pro-life Catholic and father of 7 young children,  
4           ostensibly because he obstructed access to an abor-  
5           tion clinic.

6           Former FBI special agent and federal whistle-  
7           blower Kyle Seraphin obtained a leaked FBI docu-  
8           ment that targets Traditional Latin Mass Catholics.  
9           The document, titled “Racially or Ethnically Moti-  
10          vated Violent Extremists (RMVE) and their inter-  
11          ests in ‘Radical-Traditionalist Catholics’ or RTCs,”  
12          was reported out of the Richmond Field Office and  
13          dated for January 23, 2023. This leaked document  
14          outlined a plan for the FBI to spy on Catholics, par-  
15          ticularly Latin Mass-attending Catholics, who, ac-  
16          cording to the document, have harbored “white su-  
17          premacy”. The FBI document indicated intentions  
18          to have informants within the Catholic Church, on  
19          advice from the Southern Poverty Law Center.

20          In October 2020, a group of men allegedly at-  
21          tempted to kidnap Michigan Governor Gretchen  
22          Whitmer. Several of the men were acquitted in their  
23          cases, as the FBI was found to have entrapped them  
24          in the scheme. Most of the members involved with  
25          the plot were FBI informants.

1 Not only has Director Wray persecuted political oppo-  
2 nents in an unprecedented and partisan way, but he has  
3 also overseen his agency take actions to shield and protect  
4 the current President and his family. A senior FBI official  
5 left the agency under a cloud of accusations that he shield-  
6 ed a laptop belonging to the President's son, Robert Hun-  
7 ter Biden, from a criminal probe.

8 It is unacceptable for the Director of the FBI or any  
9 civil officer to exercise his power in a way that targets  
10 one political class while doing favors for the other.

11 Wherefore, given the abovementioned unprecedented  
12 actions taken by the FBI to subvert freedom and democ-  
13 racy, and the fact that the American people deserve a  
14 transparent justice system and law enforcement that keeps  
15 them safe, not entraps them in serious criminal activity,  
16 Director Christopher Asher Wray merits impeachment.

17 ARTICLE II

18 Director Wray, in his failure to uphold the oath he  
19 took, has, by his actions, lost the trust of citizens of the  
20 United States to faithfully execute the laws of the United  
21 States.

22 Director Wray's actions run counter to the steps that  
23 employees of the Executive branch must take to avoid "an  
24 appearance of loss of impartiality".

25 Director Wray, has demonstrated that he will remain  
26 a threat to the justice system of the United States of

1 America if allowed to remain in office, and has acted in  
2 a manner grossly incompatible with democracy, self-gov-  
3 ernance, and the rule of law.

4       Wherefore, Christopher Asher Wray, thus warrants  
5 impeachment and trial, removal from office, and disquali-  
6 fication to hold and enjoy any office of honor, trust, or  
7 profit under the United States.
